

TERMS AND CONDITIONS

Competition Terms and Conditions:

The "Helloworld Scholarship to Nurture Change" (the "Competition") is run by Helloworld Travel Limited in conjunction with Nurture Change. By participating, entrants agree to be bound by these terms and conditions.

1. Eligibility

Employees and their immediate families of Helloworld, employees and contractors of Nurture Change and their immediate families are not eligible to enter.

Entrants must be New Zealand residents and over 18 years of age on November 7 2017, who hold a passport with a minimum six months' validity and do not have any prior criminal convictions.

2. Dates

Competition Period: The competition commences on Wednesday 23 August 2017 and closes at midnight, Wednesday 20 September 2017 ("Competition Period").

Winner Announcement: The winning recipient will be contacted on Friday 22 September 2017, and formally announced on Monday 25 September 2017.

Prizes: There will be two winners in total.

3. Competition Entry

Winners are responsible for and must cover the costs of any changes to travel dates or additional accommodation outside the travel period specified in the Prize details.

4. Prize Conditions

The maximum value of the Prize is correct at the time of publication. Helloworld takes no responsibility for any variation in any element of the Prize. Helloworld is not responsible for any cancellation, postponement, and delay or rescheduling of any element of the Prize. Any costs incurred will be the sole responsibility of the Prize Winner.

Nurture Change or Helloworld will not be held responsible or liable in any way if the Winners or their companions are denied entry into Fiji, or encounters any visa issues on route. Excess baggage charges must be paid by the Winners.

As part of the utilisation of travel, the Winners undertake to:

4.1: have valid documentation, including, but not limited to, valid passports and visas, which meet the requirements of immigration and other government authorities at every destination;

4.2: take responsibility to pay any fines, penalties, payments or expenditures incurred as a result of such documents not meeting the requirements of those authorities (including any costs associated with delay;

4.3: be neatly and appropriately attired when travelling;

4.4: not carry, on their person, in their luggage or carry-on baggage, any contraband or goods which are prohibited by the laws of New Zealand or Fiji, or goods which are unsuitable for carriage on a commercial aircraft;

4.5: observe all directions of ground staff and air crew at all times;

4.6. comply with the requirements of immigration and customs authorities in each country; and

4.7. comply with the laws of the jurisdiction they are visiting.

5: Terms and conditions of the accommodation provider may apply. The Winners must comply with those terms and conditions at all times. In no circumstance will the Nurture Change or Helloworld be liable for any breach of those terms and conditions, including any damage caused by the Winners or accompanying persons. The Winners also agree with the standard booking terms and conditions of Nurture Change that all passengers must agree to be able to attend Nurture Change.

6: The Prize (including the air tickets and accommodation) is not transferable or exchangeable and cannot be redeemed for cash. The Prize must be taken as stated in these terms and conditions and no compensation will be payable if the Winners are unable to use the Prize as stated. For the avoidance of doubt, if the Winners are, for whatever reason, unable to travel on a nominated date during this period, whether the failure was due to reasons beyond the Winners' control or otherwise, then the Winners will forfeit the Prize.

7: Charges for excess baggage shall apply where a passenger seeks to carry more than their entitlement of luggage. In such cases, Nurture Change or Helloworld is not liable for the charges.

8. Get themselves and any companions from their home to Auckland airport or Christchurch airport to catch the connecting flight to Fiji and upon return, they are responsible to get themselves home from Auckland airport or Christchurch airport.

The winners will be notified by telephone or email using the number / email address provided on entry. If the winners cannot be contacted within three (3) days Helloworld reserve the right to redirect the prize to another.

10: No Correspondence

Helloworld's decision regarding the Winners is final and no correspondence will be entered into.

By entering the Competition, the winner agrees to their name being published, and to be photographed and/or interviewed by Helloworld and / or Nurture Change and they may use the winners name and photographs and/or interviews for publicity purposes.

12: Ownership of Entries

Competition entries become the property of Nurture Change and Helloworld, who will keep the personal information it holds about entrants confidential and will not disclose it to third parties (unless Clause 11 applies where some information on the entrant may be shared as part of a Helloworld or Nurture Change news story.)

None of the participating companies, Helloworld or Nurture Change Ltd (or any other company or individual associated with the Competition) shall be responsible for or liable in any way (including, without limitation in negligence) in respect of: (i) any additional costs to the winners associated with the prizes, including any tax implications that may arise as a result of winning; or (ii) any loss, damage or personal injury whatsoever that is suffered or sustained (including but not limited to indirect or consequential loss) in connection with the Competition except any liability that cannot be excluded by law.
